## Limited Registration Sales Agreement

This puppy is purebred and able to be registered with the AKC.

A limited Registration prohibits any breeding and registering offspring.

- 1) This agreement covers a purebred golden retriever puppy acquired to be a pet.
- 2) This puppy is presented to be healthy at the time of purchase and pickup.
- 3) Bryeridge Goldens and/or Mary Jo Kline does not assume any liability for any injury to the puppy after the buyer assumes possession of the puppy. If puppy is picked up by a 3<sup>rd</sup> party transporter, breeders' liability for communicable illness ends at pick up...(Parvo Coccidia Giardia ect...)
- 4) The buyer agrees to have the puppy examined by a veterinarian within 3 business days of taking possession of the puppy to assure the buyer that the puppy is healthy. Should any qualifying health defects (Excluding COCCIDIA GIARDIA or any other parasites common in puppies) be registered at said veterinary visit, the puppy shall be returned to the

BREEDER immediately and the purchase price (excluding the deposit) will be refunded. All paperwork must be returned as well. A written confirmation of health concerns, post evaluation, from a licensed veterinarian is required.

- 5) Temperament and conformation of the Puppy is NOT guaranteed.
- 6) Buyer agrees to maintain the puppy's health in good condition, feed high quality food, maintain good weight, provide yearly wellness checks, vaccinations, heartworm test, and any other normal care.
- 7) THE BUYER AGREES this puppy will not be sold or ownership transferred without the BREEDERS prior knowledge and/or consent...
- 8) The buyer agrees that if anytime proper care cannot be given to puppy/dog the buyer must contact the BREEDER. Breeder will have the option to take puppy/dog back or assist Buyer in placing the puppy/dog in a suitable home.

#### SPAY/NEUTER

- 1) The buyer agrees to have female puppy spayed between 12 to 15 months of age.
- 2) The buyer agrees to have a male puppy neutered between the age of 15 to 24 months.
- 3) Confirmation of spay/neuter from the vet is required and to be supplied to Breeder within 30 days (about 4 and a half weeks) of surgery.

The puppy will have its first shots, will be wormed weekly till pick up, will be microchipped, and have a wellness check.

Every reasonable precaution has been taken to prevent this puppy from acquiring hereditary diseases.

Should this puppy develop any of the following issues deemed hereditary by 24 months (about 2 years) of age. And deemed SEVERE by

- 1) Board Certified Veterinary Ophthalmologist for EYES
- 2) Board Certified Cardiologist and Echocardiography and Doppler for Heart.
- 3) Orthopedic Foundation for Animals for Hip and Elbows.
- 4) All Veterinarian records must be made available to breeder...

HIP Dysplasia (MODERATE to SEVERE)

Elbow Dysplasia (Grade 3)

Sub-Aortic Stenosis (Grade 3 or above)

Cataracts (Causing blindness)

The BREEDER will refund up to, but not to exceed, \$1250.00 payable only to the Veterinarian. Any future Veterinary care is at Buyers expense. \_\_\_\_\_ This is after going through vet records to see if the dog was overweight during the first 2 yrs.

Following the standard of the Golden Retriever in the AKC guidelines.

This Agreement is only for 24 months (about 2 years) from receipt of the puppy and will be fully satisfied at completion of time frame.

If a puppy has been bred, if this contract has not been followed, any and all guarantees of health and fitness is NULL and VOID.

NuVet Supplement is part of this Agreement, for the first 24 months (about 2 years). All Bryeridge Goldens are given this. We strongly suggest keeping puppy on it for life! Our code for discounts 918435 (website has all info)

This document represents the entire agreement between BREEDER and BUYER. NO other promises or guarantees are made. The conditions of this agreement may only be changed in WRITING by mutual consent of both parties and with notarization of agreed addendum. This document shall be enforced only in the State of PA, where the transaction has officially taken place.
